The concept of the Turkic agro-forum

1. At the upcoming agro-forum of the member states of the Organization of Turkic States, the focus will be on expanding economic interconnections in the agro-industrial complex, including increasing trade and mobilizing investments in the implementation of mutually beneficial projects between member states and observers.

2. Date and venue of the Forum

The Turkic Agro-Forum will be held on July 4, 2022 at the «HYATT Regency» Tashkent Uzbekistan.

3. Purpose of the forum

Creation of a single discussion platform on key issues of agricultural cooperation:

- -Promoting the interaction of business circles of the participating countries in expanding trade cooperation, implementing joint projects and attracting investments and introducing advanced technologies in agriculture;
- Discussion of the best world practices to increase the investment attractiveness of the agricultural sector of the countries participating in the OTS.

4. Format of the event:

The business program consists of speeches by Forum officials, speeches and presentations of investment proposals in the agricultural sector, company projects and opportunities to expand cooperation with business structures. In addition, informal meetings and bilateral negotiations will provide a suitable place for communication, establishing new and useful contacts between forum participants.

The forum will be dedicated to the topic: "Development of cooperation in the field of agriculture in the Turkic region."

1. Welcoming speech.

Welcoming speeches will be made by the ministers of agriculture of the member states and observers of the OTS.

2. Thematic sessions:

The thematic session will include speeches by officials of relevant departments, representatives of relevant organizations and leading companies of the countries participating in the OTS, international and regional organizations, which will outline the directions for the development of the agro-industrial complex and the investment policy of their countries.

At these sessions, representatives of relevant organizations will share information on the main directions of development of the above-mentioned industry, present their initiatives and proposals leading to the expansion of mutually beneficial cooperation, as well as investment proposals and proposals for the creation of joint projects in the agro-industrial complex.

3. Informal meetings.

Bilateral meetings in the B2B format will provide an opportunity to establish new business connections and contacts.

5. Forum audience

The forum is expected to be attended by officials of relevant departments, representatives of relevant organizations and leading companies, international and regional organizations.

• In accordance with the latest decisions taken by the authorities of the Republic of Uzbekistan, passengers who meet the following conditions are allowed to enter Uzbekistan, and they will also be exempt from quarantine:

Passengers (over 12 years of age), arriving in Uzbekistan from foreign countries with a Covid-19 vaccination certificate or a vaccination passport will not be required to take a PCR or rapid test before departure.

Otherwise, passengers must present a negative PCR test on Covid-19 (valid, if taken within 72 hours) or express test.

All the above documents/certificates must have a QR code.
